

Stipendium 11th International EDiLiC Conference, Hamburg **Participation and submission procedures**

The EDILIC association supports its members!

As part of its policy of development and support for its members, the EDILIC association will offer up to 5 bursaries, for a maximum amount of 300 Euros each to support the participation of delegates whose papers have been accepted at the 11th international EDILIC Conference to be held in Hamburg from 23 to 25 July 2025.

Eligibility

To be eligible for a bursary contributing to the costs of attending the conference in person, the candidate must be a member of the Edilic association (membership dating from at least 2023, the Copenhagen conference) and must have had his/her proposal accepted by the Scientific Committee.

Only one application per eligible candidate will be accepted.

EDILIC members can apply for bursary in one of the following three categories:

1. Long-term members of the EDILIC association, i.e. a continuous member for at least the last 6 years, (2 bursaries are available)

2. Student members of the EDILIC association. The degree for which the student is registered must not be awarded before the end of the conference. Proof of student status must be attached to the application together with a letter of support from the supervising professor. (2 bursaries are available)

3. EDILIC members residing in one of the countries designated by the European Association for Educational Research as a low GDP country and other countries, as indicated in the extended list below (see the information sheet on the countries concerned) (1 bursary is available): logs.worldbank.org/fr/pendata/nouvelle-classification-des-pays-en-fonction-de-leur-revenu-2024-2025

The place of residence will be determined by the postal address currently on the EDILIC membership list.

Countries with low GDP are:

- Africa - all countries except Equatorial Guinea and the Seychelles;
- America - all countries except Canada, the United States of America, St. Kitts and Nevis and Trinidad and Tobago;
- Asia - all countries except Bahrain, Brunei Darussalam, Hong Kong SAR, Israel, Japan, Republic of Korea, Kuwait, Macao, Malaysia, Oman, Qatar, Singapore, Taiwan, UAE;
- Australasia/Oceania - all countries, except Australia and New Zealand;
- Europe - Albania, Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, Bulgaria, Croatia, Georgia, Kazakhstan, Kosovo, North Macedonia, Moldova, Montenegro and Ukraine.

Fellowship applicants may be the main author or co-author of the paper. Only one person may be funded per presentation/proposal.

It should be noted that an application for a bursary submitted by a person who was not a member during the 2023-2025 period will not be considered. If a person received support at the previous conference, they will not be given priority over other requests.

Bursary applications will be accepted after confirmation by the organizers of the acceptance of the abstract (the confirmation email must be attached to the application).

The committee reserves the right not to award bursary in any category and to consider awarding the sum of money left over after the award of bursary in these three categories to the next candidate on the list, as appropriate.

Once the bursary has been awarded, the amount will be paid **after the conference** by bank transfer on condition that proof of payment of costs relating to participation in the conference (e.g. registration fees and travel and hotel expenses) and covering the amount of the bursary are received before 25 September 2025. No one will receive more than 300 euros, but they may receive less. The amount of the bursary will be defined in euros. Exchange rates between currencies may affect the amounts received by applicants.

Note: In the event of the cancellation of in person congress attendance due to ill health or any other unforeseen event beyond the control of the organisers, the stipendium will also be cancelled.

The decisions of the bursaries Committee will be based entirely on the information provided by the applicants in their application forms.

Schedule:

- Applications must be submitted by midnight (CET) 21st February 2025 to the EDILIC email address: edilicmail@gmail.com
- The committee's response will be sent by 20th March 2025.
- The payment of the bursary, by bank transfer on presentation of invoices, no later than 25th September 2025.
